## SUMMARY ANNUAL REPORT FOR AUTOMATIC SPRINKLER LOCAL 281 U.A. WELFARE FUND

This is a summary of the annual report for Automatic Sprinkler Local 281, U.A. Welfare Fund, EIN 36-2242666, for the year ended December 31, 2021. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). The Fund has committed itself to pay certain medical, dental, vision, prescription drug and time loss claims.

## **Insurance Information**

The plan has contracts with The Union Labor Life Insurance Company, Dearborn Life Insurance Company, Ameritas Life Insurance Corp. and Humana Insurance Company to pay stop loss, specific life and accidental death and dismemberment claims, vision claims, and Medicare eligible claims incurred under the terms of the plans. The total premiums paid for the policy years ending January 31, 2021, and December 31, 2021, was \$2,026,745 and \$372,120, respectively.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$40,673,398 as of December 31, 2021, compared to \$36,076,890 as of January 1, 2021. During the plan year, the plan experienced an increase in its net assets of \$4,596,508. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$26,570,821 including (but not limited to) employer contributions of \$21,279,405, participant contributions of \$982,200, other contributions of \$1,093,949, and a gain from investments of \$2,125,796. Plan expenses were \$21,974,313. These expenses included \$1,311,775 of administrative expenses and \$20,662,538 in benefits paid to participants and beneficiaries.
